<sup>3</sup> A 'connected person' in relation to a FIT Generator or a Nominated Recipient, means any person connected to that person within the meaning of section 1122 of the Corporation Tax Act 2010.

<sup>4</sup> Only to be completed where there is a Nominated Recipient.
