Business Deemed Principle Terms

If you choose to sign up to Good Energy's Partnership agreement you will be in a legally binding contract with Good Energy. The key terms are outlined below:

If you are a Micro Business Customer and you choose to switch supplier, your contract will end automatically when the switch takes effect.

If you are not a Micro Business Customer you can cancel your contract at any time by giving us at least 30 days' written notice provided that you have paid us any monies you owe us and started receiving electricity or gas (or both) from another supplier.

As your tariff type is variable, the prices you pay for your energy may change. We will give you prior notice of any change and provide information relating to the new prices.

If we need to make any changes to your contract that could put you at a disadvantage we will inform you of these prior to the changes taking effect.

Prices exclude VAT (business charged at 20%, de minimus customers and registered charities at 5%).

Good Energy may share your information with credit reference agencies to help us make decisions about providing services and credit.

Good Energy may ask for a reasonable security deposit or other form of security before or during the period of the contract.

Please ensure that you have cleared any outstanding balance on your existing account, or you will be unable to join Good Energy.

Please check your existing contract end date finishes before the agreed start date with Good Energy or you will be unable to switch.
